CINCO DE MAYO
GUIDELINES (REGLAS)**

The 41st Annual Cinco de Mayo celebration will be held on **Saturday, August 28, 2021**, on **Main Street, between 4th and 7th Street, in Grand Junction, Colorado.**

The City is requiring a **Certificate of Liability Insurance**. You may get this from your Insurance Company. You will also need to include in the form that Latin Anglo Alliance Foundation (LAAF) will be additional insured under your Insurance Company.

VENDOR FEES: Applications should be submitted by July 16,2021.

PROFIT (Businesses and individuals): \$175.00 + \$50.00 deposit fee. **12 spaces available near the stage.** First come, first served.

NON PROFIT \$50.00 + \$50.00 deposit.

A **“SEPARATE ‘DEPOSIT’ CHECK”** IS REQUIRED. (This check will be returned to you at the end of the evening or when you close your booth. Please check with a Latin Anglo Alliance member to get your deposit check back.

Health Department Regulations

‘Food vendors’ are to apply at the Health Department for a permit and fill out the ‘application’ to sell food. Call 248-6920 or <http://www.health.mesacounty.us/environment> for cost, and requirements. **Please make sure to get the ‘Approval Letter’ from the Health Dept. and send it with your Cinco de Mayo application 30 DAYS BEFORE THE EVENT.**

Requisitos del Departamento de Salud

Vendedores de comida deben de aplicar con el Departamento de Salubridad por un permiso y completar la aplicación para vender comida. Llaman al 248-6920 o <http://www.health.mesacounty.us/environment> Para más información de costos y requisitos. Por favor asegúrese de juntar la **“Carta de Aprobación”** del **Depto. de Salud y Mandela con la aplicación de Cinco de Mayo 30 DIAS ANTES DEL EVENTO.**

Locations for Food booths have ‘electrical plug-ins’. We also suggest that you bring your own fire extinguishers, water, tables, chairs, and trash barrels.

Each group or organization will be responsible for securing its own **Sales Tax Permit** from the City of Grand Junction and the State of Colorado. This must be done prior to the event. **Vendors must provide a Certificate of Liability Insurance from their Insurance Company, naming Latin Anglo Alliance Foundation as additional insured. Please send a copy with your Cinco de Mayo Application.** Each participant must provide his or her own insurance.

Opening ceremonies and festivities will begin promptly at 10:00 a.m. **All booths must be set up and ready to go no later than 9:00 a.m.** The streets will not be blocked off the previous evening. If you plan to set up the night before, neither, the Cinco de Mayo Committee or the Latin Anglo Alliance Foundation will be responsible for lost or stolen items or for vandalism.

NOTE: LAA will not be responsible for the effects of inclement weather or any legitimate condition that is beyond its control. Booth fees WILL NOT be returned after July 16th due to Vendor cancellation.

Street dance starts at 6:00 pm. Booths are welcome to stay open throughout the evening, although you will need to provide your own lighting. **The dance will end at 10:00 p.m.**

***All vendors will need to contact an LAA member before leaving their area in order to get their Deposit Check back. If you do not contact an LAA member, your deposit will not be returned.**
